MINUTES OF THE OCTOBER 28, 2025
REGULAR COMMISSION MEETING

The Board of Commissioners of Public Utility District No. 1 of Franklin County, Washington held a regular meeting at 1411 W. Clark St., Pasco, WA, on October 28, 2025, at 8:30 a.m. Remote technology options were provided for the public to participate.

Those who participated from the District via remote technology or in person for all or part of the meeting included Commissioner Roger Wright, President; Commissioner Bill Gordon, Vice-President; Commissioner Pedro Torres, Secretary; Victor Fuentes, General Manager/CEO; Steve Ferraro, Assistant General Manager; Katrina Fulton, Finance and Customer Service Director; Rosario Viera, Public Information Officer; Mark Hay, Engineering & Operations Director; Tyler Whitney, General Counsel; Terry Cruz, Senior IT Systems Administrator; and Jessica Marshall, Executive Assistant.

Public participating via remote technology or in person for all or part of the meeting included Isaac Kastama, Principal Lobbyist and Adan Espino, Associate Lobbyist with Water Street Public Affairs.

OPENING

Commissioner Wright called the meeting to order at 8:30 a.m. and asked Mr. Cruz to lead the Pledge of Allegiance.

PUBLIC COMMENT

Commissioner Wright called for public comment and none was provided.

EMPLOYEE MINUTE

Commissioner Wright welcomed Mr. Cruz and asked general questions about his current position, tasks his position entails, favorite parts of the job, his professional growth at the District and what safety improvements or changes he has seen over the course of his employment.

Mr. Cruz reported that he has been with the District for about one year and briefly described his job duties within the IT Department. Mr. Cruz noted his enjoyment with working within the IT team. He noted that it feels like a family at the District.

Commissioner Wright reported that the Commission believes strongly in Safety First and asked if there were any improvements that could be made. Mr. Cruz did not have any suggested

safety improvements at this time and reported that he feels the Customer Service lobby remodel improves safety for employees.

Commissioner Wright thanked Mr. Cruz for his attendance.

LEGISLATIVE UPDATES

Commissioner Wright welcomed Mr. Kastama and Mr. Espino.

Mr. Kastama and Mr. Espino provided a 2025 Legislative Update and 2026 Preview presentation that included a summary of the 2025 legislative session, the notable bills that were considered, bills that passed, 2025 post-session special elections, and information on the upcoming legislative session. There were questions and discussions throughout the presentation.

The Commission thanked Mr. Kastama and Mr. Espino for attending the Commission meeting.

Mr. Kastama and Mr. Espino left the Commission meeting.

COMMISSIONER REPORTS

Commissioner Gordon reported that:

• He participated in an Energy Northwest plant tour and shared takeaways from the visit.

Commissioner Torres reported that:

• He attended a transmission discussion with Senator Boehnke on October 17, 2025, and reviewed notes from that meeting.

Commissioner Wright reported that:

- The NoaNet Board Meeting was held at Mason 3 PUD. He reviewed notes from the meeting and noted that Broadinc was welcomed as a new member.
- He attended Energy Northwest committee meetings last week and reviewed notes and presentations from the meeting.
- A discussion regarding a potential addition of a new member to NoaNet will take place later in today's Commission meeting.

AGENDA ITEM 7, PROVIDING AN UPDATE ON THE APPLICATION AND USE OF SMART METER DATA COLLECTED THROUGH THE DISTRICT'S AUTOMATED METERING INFRASTRUCTURE (AMI) SYSTEM

Ms. Borchers provided a Smart Meters presentation and reviewed the background on the smart meter deployment project which began in December 2021 and was completed in June 2022, advantages for both the District and customers, understanding power usage and a live outage map both of which can be found on the SmartHub Application.

There were questions and discussion throughout the presentation which included types of outage notifications staff receive after-hours, how meter data is used for rate design, and the cost-savings of incorporating smart meters.

At 10:30 a.m., Commissioner Wright called for a 10-minute break.

At 10:40 a.m., Commissioner Wright reconvened the Commission meeting.

AGENDA ITEM 8, RE-OPENING THE 2026 BUDGETS PUBLIC HEARING, PRESENTING THE PRELIMINARY 2026 OPERATING AND CAPITAL BUDGETS, AND RECESSING THE PUBLIC HEARING

Commissioner Wright re-opened the public hearing for the 2026 Operating and Capital Budgets and called for public comment and none was provided. He called on Ms. Fulton for presentation of the agenda item.

Ms. Fulton presented the 2026 Operating Budget Crosswalk and 2026 Capital Budget by Project (Attachment A and B of the Agenda Item). She reported that the updated 2026 Capital

Budget by Project included an increase under Building, Property Acquisition. A brief discussion was held on this increase, the future of downtown Pasco, and having a facilities assessment completed.

Motion by Commissioner Torres, seconded by Commissioner Gordon to recess the 2026 Operating and Capital Budgets Public Hearing to the November 12, 2025 Regular Commission Meeting.

THE MOTION PASSED UNANIMOUSLY.

AGENDA ITEM 9, AUTHORIZING THE GENERAL MANAGER/CEO OR HIS DESIGNEE TO EXECUTE AN AMENDMENT TO CONTRACT 10311, POWER PURCHASE AGREEMENT WITH PALOUSE JUNCTION SOLAR, LLC

Ms. Fulton introduced the agenda item and reviewed the information as reported on the Agenda Item Summary included in the meeting packet. Since the original agreements were executed in April 2025, the One Big Beautiful Bill Act was signed into law and tariff percentages have increased. The existing PPA includes terms that allow the contract to be modified if a change in law arises that has the effect of materially modifying the economic benefits and burdens to the parties under the agreement.

A brief discussion was held on tariff's and updates related to the project's timeline were given.

Motion by Commissioner Gordon, seconded by Commissioner Torres authorizing the General Manager/CEO or his designee to execute an amendment to Contract 10311, Power Purchase Agreement with Palouse Junction Solar, LLC.

MOTION PASSED UNANIMOUSLY.

AGENDA ITEM 10, REVIEWING THE 2025 CONSERVATION POTENTIAL ASSESSMENT (CPA) REPORT FOR THE DISTRICT

Ms. Fulton provided a Conservation Potential Assessment (CPA) presentation that included a review of Initiative 937: Energy Independence Act (EIA), results of the 2025 CPA report, comparison from the 2023 to 2025 assessment, updates to assumptions and recent conservation achievements.

She noted that this information has been posted to the District's website and staff will bring the conservation potential and biennial targets as were presented today to the December Commission meeting for consideration of approval.

AGENDA ITEM 11, ADOPTING A RESOLUTION FINDING DISTRICT PROPERTY SURPLUS AND AUTHORIZING THE DISPOSAL OF THE SURPLUS PROPERTY

Commissioner Wright requested the Commission hold a discussion on the Keystone TREK (Traveling Renewable Energy Kiosk) which is being brought forward on the list of items to surplus (Exhibit A of the Resolution).

Mr. Ferraro introduced the agenda item and reviewed the information as reported on the Agenda Item Summary included in the meeting packet. He also reviewed the District's Surplus Policy and costs required to update the TREK to a functional state. Commissioner Wright noted that the TREK was originally purchased and used for the purpose of educating the community on renewables. He requested staff research other manners where this could be done.

Motion by Commissioner Torres, seconded by Commissioner Gordon adopting Resolution 1439 as presented.

MOTION PASSED UNANIMOUSLY.

AGENDA ITEM 12, AUTHORIZING THE GENERAL MANAGER/CEO OR HIS DESIGNEE TO EXECUTE A POWER SALES AGREEMENT WITH THE BONNEVILLE POWER ADMINISTRATION (BPA)

Mr. Fuentes introduced the agenda item and reviewed the information as reported on the Agenda Item Summary included in the meeting packet. A brief discussion was held on the terms of the Power Sales Agreement offer received from BPA, as well as the built-in one-time chance to off ramp.

Motion by Commissioner Torres, seconded by Commissioner Gordon authorizing the General Manager/CEO or his designee to execute the Power Sales Agreement with BPA. MOTION PASSED UNANIMOUSLY.

AGENDA ITEM 13, AUTHORIZING THE GENERAL MANAGER/CEO TO ADD A NEW POSITION TITLE IN THE CURRENT SALARY ADMINISTRATION PLAN

Mr. Fuentes introduced the agenda item and reviewed the information as reported on the Agenda Item Summary included in the meeting packet.

Motion by Commissioner Gordon, seconded by Commissioner Torres authorizing the General Manager/CEO to add a new position title as presented in the current Salary Administration Plan.

MOTION PASSED UNANIMOUSLY.

AGENDA ITEM 14, PROVIDING AN UPDATE ON THE 2024-2025 OPERATING PLAN AND PRESENTING THE PROPOSED 2026-2027 OPERATING PLAN

Mr. Fuentes provided updates on tactics from the 2024-2025 Operating Plan listed on Attachment A of the agenda item. Staff plans to return to the December Commission meeting to provide a final update and will request the Commission approve the closing of the District's 2024/2025 Operating Plan.

Mr. Fuentes presented the proposed 2026-2027 Operating Plan listed on Attachment B of the agenda item. Staff requested the Commissioners review the proposed Operating Plan for years 2026-2027 and provide feedback to him or during the November Commission meeting. Staff will incorporate any Commission feedback and bring back for final review and

consideration of approval to the December Commission meeting.

AGENDA ITEM 15, DISCUSSING THE 2026 REGULAR COMMISSION MEETING SCHEDULE

Mr. Fuentes introduced the agenda item and reviewed the information as reported on the Agenda Item Summary included in the meeting packet.

A discussion was held on the February and May Commission meeting dates. Staff will forward proposed dates to the Commissioners for their review and feedback. Staff plans to return to the December Commission Meeting for final review and consideration of approval.

MANAGEMENT REPORTS

GENERAL MANAGER/CEO REPORT

Mr. Fuentes reported that:

- He and Mr. Whitney provided an update on the Ruby Flats Solar Project and reviewed contract terms. A brief discussion was held, and Commissioners requested an executive session at the end of today's Commission Meeting to continue the conversation as allowed per RCW 42.30.110(1)(i).
- He plans to attend the WA2040 Energy Solution Summit on Thursday, October 30, 2025, and will share takeaways during the November Commission Meeting.

FINANCE & CUSTOMER SERVICE DIRECTOR REPORT

Ms. Fulton reported that:

- The September 2025 KPI's were included in the Commission packet, and she reviewed pertinent slides from within the report.
- The District will become a binding participant in the Western Resource Adequacy Program (WRAP) beginning October 2027. Ms. Fulton shared the background of WRAP, and that the District's participation will be through The Energy Authority.
- Staff is working on a renewal for the Nine Canyon Wind Farm contract.
- Staff are reviewing proposals received for the Battery Storage Project. Staff plans to provide a battery storage presentation during a future Commission meeting.
- She performed an invoice audit on a line item from the September 2025 Warrant Register included in the commission packet.

ENGINEERING & OPERATIONS DIRECTOR

Mr. Hay reported that:

- He began his position with the District on September 29, 2025 and provided a brief overview of his background.
- The outage that occurred over the weekend was due to a broken hot line tap resulting in about 628 customers without power for about one hour and three customers without power for about five hours.

ASSISTANT GENERAL MANAGER REPORT

Mr. Ferraro reported that:

- The wellness event has been rescheduled to November 20, 2025, and noted a remote option will be available for those unable to attend in person.
- Interviews are being conducted this week for the open Electrical or System Engineer position.
- The District's open enrollment will run from November 1st through November 24, 2025.
- Staff are reviewing the Milliman survey data and will present any recommended changes to the Salary Administration Plan at the November Commission meeting.
- Local union negotiations will begin next week, and he provided a brief overview of past practices.
- He gave a brief update on the Power Upgrade Project.
- Hearing tests were completed for Operations employees.

EXECUTIVE ASSISTANT

Ms. Marshall reported that:

- The November 12, 2025 Commission Meeting will be held on Wednesday due to the Veteran's Day holiday.
- The WPUDA November Association Meetings will be held November 12-14, 2025 in Olympia and via remote technology.
- The PPC and PNUCC Annual Meetings are scheduled for November 5-7, 2025 in Portland, OR.
- The hotel room block for the APPA Legislative Rally will open on November 3, 2025.
- Mr. Fuentes will provide a State of the PUD presentation during the November 10, 2025 Pasco Chamber Luncheon.
- Wall calendars will be distributed before the end of the year.

EXECUTIVE SESSION

At 12:00 p.m., Commissioner Wright called for an executive session to conclude at 12:15 p.m. He reported that the purpose the of the executive session were the following reasons:

- RCW 42.30.110(1)(i): to discuss with legal counsel representing the agency matters relating to agency enforcement actions, or to discuss with legal counsel representing the agency litigation or potential litigation to which the agency, the governing body, or a member acting in an official capacity is, or is likely to become, a party, when public knowledge regarding the discussion is likely to result in an adverse legal or financial consequence to the agency.
- RCW 42.30.110(1)(c): to consider the minimum price at which real estate will be offered
 for sale or lease when public knowledge regarding such consideration would cause a
 likelihood of decreased price.

At 12:15 p.m., Commissioner Wright extended the executive session to conclude at 12:20 p.m., for the same two reasons listed previously.

At 12:20 p.m., Commissioner Wright ended the executive session and reconvened the regular meeting.

1. OBJECTIVE:

Adopting the 2025 Clean Energy Implementation Plan (CEIP) in accordance with RCW 19.405.060.

2. BACKGROUND:

Washington's Clean Energy Transformation Act (CETA) was signed into law in 2019 and requires utilities to submit a plan outlining the District's transition to 100% clean electricity. RCW 19.405.060 requires utilities to create a four-year clean energy implementation plan to meet CETA requirements. This plan is required to be adopted by the governing board and be made available to the public. The CEIP will be submitted to the Washington Department of Commerce by January 1, 2026 in accordance with state law. The CEIP is provided as Attachment A to this agenda item.

Over the course of this year, staff worked with a consultant to develop the CEIP, incorporating several elements required by CETA:

- Establishes interim targets for the percentage of retail load to be served using renewable and non-emitting resources
- Establishes specific targets for MWh to be used by renewable energy, energy efficiency, and demand response
- Defines specific actions to ensure an equitable transition to clean energy
- Identification of highly impacted communities and vulnerable populations
- Public participation in formation of the CEIP
- Consistency with other long-term plans (Integrated Resource Plan)
- Identification of resource adequacy standards used for planning

Staff will review the CEIP through a presentation. Staff recommends the Commission adopt the Clean Energy Implementation Plan in accordance with RCW 19.405.060.

Relevant Clean Energy Transformation Act Statutes and Rules

RCW 19.405.060

Clean energy implementation plan—Compliance criteria—Incremental cost of compliance.

(2)(a) By January 1, 2022, and every four years thereafter, each consumer-owned utility must develop and submit to the department a four-year clean energy implementation plan for the standards established under RCW 19.405.040(1) and 11,905.050(1) that: (i) Proposes interint argets for meeting the standard under RCW 19.405.040(1) during the years priot to 2030 and Detween 2030 and 2045, as well as specific targets for energy efficiency, demand response, and renewable energy; (ii) Is informed by the consumer-owned utility's clean energy action plan developed under RCW 19.280.030(1) or other ten-year plan developed under RCW 19.280.030(1); (iii) Is consistent with subsection (4) of this section; and (iv) Identifies specific actions to be taken by the consumer-owned utility over the next four years, consistent with the utility's long-range resource plan and resource adequacy requirements, that demonstrate progress towards meeting the standards under RCW 19.405.040(1) and 19.405.050(1) and the interim targets proposed under (a)(i) of this subsection. The specific actions identified must be informed by the consumer-owned utility's historic performance under median water conditions and resource capability and by the consumer-owned utility's participation in centralized markets. In identifying specific actions in its clean energy implementation plan, the consumer-owned utility has been unplanded loss or addition of load it experiences.

(b) The governing body of the consumer-owned utility must, after a public meeting, adopt the consumer-owned utility's clean energy implementation plan. The clean energy implementation plan must be submitted to the department and made available to the public. The governing body may adopt more stringent tragest shan those proposed by the consumer-owned utility and periodically adjust or expedite timelines if it can be demonstrated that such targets or timelines can be achieved in a manner consistent with the following: (i) Maintaining and protecting the safety, reliable operation, and balancing of the electric system; (ii) Planning to meet the standards at the lowest reasonable cost, considering risk; (iii) Ensuring that all customers are benefiting from the transition to clean energy. Through the equitable distribution of energy and nonenergy benefits and reduction of burdens to vulnerable populations and highly impacted communities; long-term and short-term public health and environmental benefits and reduction of costs and risks; and energy security and resiliency; and (iv) Ensuring that no customer or class of customers is unreasonably harmed by any resulting increases in the cost of utility-supplied electricity as may be necessary to comply with the standards.

(4)(a) A consumer-owned utility must be considered to be in compliance with the standards under RCW 19.405.040(1) and 19.405.050(1) if, over the four-year compliance period, the average annual incremental cost of meeting the standards or the interim targets established under subsection (2) of this section meets or exceeds a two percent increase of the consumer-owned utility's retail revenue requirement above the previous year. All costs included in the determination of cost impact must be directly attributable to actions necessary to comply with the requirements of RCW 19.405.040 and 19.405.050.

(b) If a consumer-owned utility relies on (a) of this subsection as a basis for compliance with the standard under RCW 19.405.040(1), and it has not met eighty percent of its annual retail electric load using electricity from renewable resources and nonemitting electric generation, then it must demonstrate that it has maximized investments in renewable resources and nonemitting electric generation prior to using alternative compliance options allowed under RCW 19.405.040(1)(b).

WAC 194-40-200

Clean energy implementation plan.

(1) Specific actions. CAISO does not break out the load variation portion. * Midcontinent Independent System Operator (MISO): Forecasted coincidental hourly peak loads are increased by about 8% for load variation and 7% for outages (contingencies).

1. OBJECTIVE:

Adopting a Resolution Approving a Revised Salary Administration Plan for Regular Non-Bargaining Employees and Superseding Resolution 1437.

2. BACKGROUND:

The Salary Administration Plan (SAP) provides the compensation structure and salary grades for non-bargaining employees of the District. It is the District's intent to review the SAP annually to ensure appropriate compensation for regular non-bargaining positions and that these positions are placed in the proper salary grade based on market survey data.

The last revision to the SAP was in October 2025 and included the addition of one new position title, approved by motion.

A review of market survey data indicates that the SAP needs to be adjusted to keep in line with the market. The proposed changes are shown on Attachment A and reflect the incorporation of the new position title approved by motion during the October 28, 2025 Commission meeting, addition of two new position titles, re-grading of various position titles, the market adjustment for the salary grades, and addition of one new salary grade.

Staff recommends that the Commission adopt Resolution 1440, approving the Salary Administration Plan for Regular Non-bargaining employees, as shown in Exhibit A of the Resolution, effective November 12, 2025.

RESOLUTION 1440

A RESOLUTION OF THE BOARD OF COMMISSIONERS OF PUBLIC UTILITY DISTRICT NO. 1 OF FRANKLIN COUNTY, WASHINGTON

APPROVING THE SALARY ADMINISTRATION PLAN FOR REGULAR, NON-BARGAINING EMPLOYEES, EFFECTIVE NOVEMBER 12, 2025, AND SUPERSEDING RESOLUTION 1437

WHEREAS, RCW 54.16.100 requires that the General Manager/CEO of Public Utility District No. 1 of Franklin County (the District) recommend to the Board of Commissioners (the Commission) the compensation for regular non-bargaining employees; and

WHEREAS, the Commission deems it in the best interest of the District to provide a compensation plan (Salary Administration Plan) by salary grade for its regular, non-bargaining employees, in accordance with job classifications and related rates of compensation, based on job difficulty, responsibility, and required qualifications; and

WHEREAS, the Salary Administration Plan establishes minimum, mid, and maximum salary rates within each salary grade based on comparable industry positions, and reflects the needs and compensation philosophy of the District; and

WHEREAS, the current Salary Administration Plan was last approved on June 24, 2025, via Resolution 1437, and

WHEREAS, the Salary Administration Plan was revised on October 28, 2025 by motion to include the addition of one new position title, and

WHEREAS, the Salary Administration Plan should be reviewed annually to ensure that positions are placed in the proper salary grade based on market survey, and

WHEREAS, after analyzing the most current market survey data it was determined that the Salary Administration Plan needed to be adjusted to keep in line with the market, and

WHEREAS, the General Manager/CEO has concluded that the minimum, mid, and maximum salary rates within each salary grade need to be adjusted to align with the current market, and

WHEREAS, the Salary Administration Plan has been revised to include the incorporation of the new position title approved by motion during the October 28, 2025 Commission meeting,

addition of two new position titles, re-grading of various position titles, market adjustment for the salary grades, and addition of one new salary grade, now therefore

BE IT HEREBY RESOLVED that effective the date of this Resolution the Salary Administration Plan for regular, non-bargaining employees attached hereto as Exhibit A to this Resolution is approved.

BE IT FURTHER RESOLVED that the General Manager/CEO is authorized to administer the Salary Administration Plan, subject to the following conditions:

- 1. The General Manager/CEO will not, without further authorization from the Commission:
 - a. Add new position titles or re-grade position titles in the Salary Administration Plan; or
 - b. Increase or decrease the minimum, mid, or maximum salary rates specified in the Salary Administration Plan.
- 2. The General Manager/CEO is authorized to:
 - a. Hire employees to fill positions specified in the Salary Administration Plan;
 - b. Promote or demote employees from one position or salary grade to another;
 - c. Set or adjust actual employee salaries within a salary grade; and
 - d. Hire temporary, on-call, seasonal or student employees provided the approved budget includes funding for such hires.

BE IT FURTHER RESOLVED that Resolution 1437 is superseded.
